RCU Members may seek election to open positions for RCU's Board of Directors via one of the following methods:

- **Application:** Any Member 18 years or older may apply for nomination by submitting the enclosed "Application to Serve as a Redwood Credit Union Volunteer" to the Nominating Committee. All applications and candidate statement information must be received no later than 5:00pm Friday, February 6, 2026. Please be aware that the application process does not guarantee an applicant's nomination. The final decision rests with the Nominating Committee.
 - Current and former employees (within the past 5 years), and members of the immediate family of a current or former employee, are deemed by the credit union to have an inherent and unavoidable conflict of interest. For that reason, such persons will not be eligible to serve as a volunteer.
- **Nomination by Petition**: Any Member 18 years or older may be nominated by obtaining the signatures of at least 257 RCU Members on the enclosed "Nominating Petition." All petitions and candidate statement information must be received no later than 5:00pm Friday, February 6, 2026. Submission of a valid petition guarantees the applicant's inclusion as a candidate.

Applications and petitions are to be submitted via one of the following:

RCU's Nominating Committee will review all applications and may contact candidates for an interview before completing the nomination process.

Candidates submitting an application are subject to nomination by the RCU Nominating Committee. To guarantee nomination by petition, the petition below must be completed with the hand-written, printed name, signature and account number (last four digits of account number only) of at least 257 valid Members of Redwood Credit Union.

Completion of the nomination by petition process guarantees a candidate's inclusion on the election proxy. To complete the nomination by petition process, a completed Application to Serve as a Credit Union Volunteer, Candidate Statement, and Petition must be submitted as stated in the cover letter of this election packet.
